

# RULES AND AGREEMENT FOR ONLINE REGISTRATION TO ATTEND THE MMF AGA

## FUNDAMENTAL RULES

- 1. ONLY RED RIVER MÉTIS ON THE MMF CITIZENSHIP REGISTER (HAVING A V#) MAY MOVE MOTIONS, SPEAK TO MOTIONS, OR VOTE FROM THE ONLINE PLATFORM.**
2. By registering to attend virtually, the citizen or other participant acknowledges these rules and agrees to comply with and be bound by them.
3. Access to the platform may be withdrawn for a breach of the rules.
- 4. The accidental or other delay, interruption or inability to provide a platform shall NOT invalidate the proceedings and the meeting. All votes within the meeting may continue despite any such inability or delay.**
5. No person shall be allowed to vote by proxy or use another person's credentials.
6. Every person attending virtually and wishing to vote must have a discreet email address.
7. The citizen or other person attending virtually is responsible for ensuring their Internet connection and that they have the necessary information to connect with the MMF virtual platform. All persons are to carry distinguishing identification.

## ATTENDANCE RULES

8. **CITIZENS ATTENDING WILL BE VETTED USING VALIDATION BY CRO AS TO THEIR CITIZENSHIP. NON-CITIZENS MAY ONLY ATTEND VIRTUALLY WITH AN APPLICATION AND PERMISSION BY THE CONFERENCE COORDINATOR, CHAIRS OF THE MEETING, OR THE ONLINE MODERATOR.**
9. All virtual attendees shall have an equal right to participate and vote on matters before the Assembly.
10. **Everyone who wishes to attend virtually shall register and be approved for online participation (hereafter “on-line attendees”). Once registered, citizens will participate virtually, although if a permanent interruption occurs in the platform, citizens may be allowed, subject to space, in person.**
11. Persons who register for online participation must attend from the IP address and email address they registered.
12. The Online Coordinator will cause each registrant attending virtually from their computer (hereinafter “Online Attendees”) to be given a code to allow admission with an invitation to the link. Registrants will not share their link.
13. Only one person may use any code for online attendees to enter virtual attendance.

## **PARTICIPATION RULES**

14. Virtual attendees will comply, with such changes as are necessary, with all other rules for voting, speaking, or other participation.
15. No person shall cause any interference in or disruption of the proceedings.
16. Questions or speeches by online citizens require acknowledgement by the online moderator and then recognition by the Chair. No direct participation in the meeting will be allowed for online participants.
17. If an online participant fails to observe the rules of procedure or the rulings or discretion of the Chair, their access may be withdrawn by the online moderator.
18. By registering, the participant acknowledges that online participation is done as a courtesy and assistance to citizens.
19. Additional rules and the general rules of the Assembly will be posted on the website and available for online participants after being approved and throughout the Assembly.
20. Registrants agree to be bound equally by any subsequent, additional, or amended rules.
