

#### **MCJP and TCJP Program Statistics:**

Number of Referrals	Youth	Adult	Total
2022/2023	9	84	93

**2022/2023:** Métis Community Justice Workers Accepted 93 diversion referrals that encompassed a total of 100 charges from 35 different communities that spanned over 18 Different types of Criminal Code Offenses diverted from the Courts.

Most diverted charge was Assault at 57%. This is a direct result of our Governments commitment to provide access to programming in the areas of Anger Management and Domestic Violence as apart of Court Diversion.



## Métis Court Work Program

#### **Overview**

The Métis Court Work Program has been developed over the fiscal year to facilitate and enhance access to justice by assisting Red River Métis Citizens involved in the court system.

The MMF has been provided with 3 Métis Court Workers to service our citizens in the following areas:

Southwest Region – Office Location will be at the Southwest Regional Office – Courts included Brandon, Minnedosa, Virden, Russell, Killarney and Rossburn.

Interlake – Courts included Selkirk, Beausejour, Arborg, Ashern, Lundar, Stonewall, Gimli and St. Martin.


Winnipeg – Courts included 408 York, St. Boniface and Manitoba Youth Centre.

The Program is in the initial stages of implementation as the program is a joint program between MMF, Manitoba and First Nations.


### Red River Métis Engagement with the Indigenous Justice Strategy Overview:

The Red River Métis Justice Strategy Project is a two-year project that supports the development of a Red River Metis focused component in the planned co-developed Federal Indigenous Justice Strategy.

The strategy will be developed through a multi-stage process of research, collaboration with Elders and Knowledge Keepers, MMF Departments and Red River Métis Citizens.

The project will inform Justice Canada with a Red River Métis-led vision of justice system reforms. The project has completed two thirds of its deliverables to inform the vision document that includes: River Metis specific traditions of law and justice to inform sectors as they relate to community safety, crime prevention, accountability, and rehabilitation.

The planned activities to complete our Strategy is to undertake an engagement with Red River Métis Citizens to further inform our Métis specific vision document.




## Métis Family Support Project


